Pursuant to DepEd Regional Memorandum No. CLMD-2024-166 re 2024 Regional Festival of Talents, this Office informs the field of the conduct of the activity on May 9-11, 2024 with the theme "Galing, Talino, at Husay ng mga Batang Makabansa sa Diwa ng Matatag na Adhika". The venue of the said activity will be announced through a separate memorandum.

The events to be contested in the Regional Festival of Talents, including the participants, coaches, and Division Personnel in-charge who shall attend the contest are stipulated in the attached enclosure.

The Division Focal person of the different events shall provide the specific guidelines to the coaches and contestants.

The contestants are expected to conduct rehearsals and practice for the contest between 1:00 p.m. to 4:00 p.m. daily to ensure their preparedness for the upcoming competition. However, the coaches must ensure that the safety and well-being of the students shall be given an utmost priority. In the event that the temperature is not conducive for practice, the teacher shall have an option not to hold a training or rehearsal. Likewise, when DepEd Central Office or the Division office will declare asynchronous learning, the coach shall secure parent's consent stating their permission for the participation of the scheduled practice.

The participation to this event is voluntary and shall not, in any way, affect the timeon-task of teachers as this activity's target learning standards and competencies are already embedded in teachers' actual classroom teaching and assessment process.

There shall be no registration for the 2024 RFOT. The travelling expenses, provision on food and other expenses shall be charged to Division MOOE/School MOOE or other eligible fund sources, all subject to the usual government accounting and auditing rules and regulations.

Further, all shall be entitled to service credits in accordance with DepEd Order No. 53 s. 2003 entitled: Updated Guidelines on the Grant of Vacation Service Credits to Teachers and Compensatory Time-Off (CTO) as per Civil Service Commission (CSC) and Department of Budget and Management (DBM) Joint Circular No. 2 s. 2004 on Non-Monetary Remuneration for Overtime Service Rendered on Saturday.
