- To fulfill this commitment, DepEd, with the guidance of the Office of the President, recognizes the urgency of reverting the school calendar to the pre-pandemic opening of classes.
- In view of the foregoing, the provision of Paragraph 6, specifically bullet 4 of DepEd Order (DO) No. 003, s. 2024, Amendment to DepEd Order No. 022, s. 2023 (Implementing Guidelines on the School Calendar and Activities for School Year 2023-2024) shall be amended and read as follows:
 - Start and End of SY 2024-2025. SY 2024-2025 shall start on July 29, 2024, Monday and end on April 15, 2025, Tuesday.
- All Orders and issuances inconsistent with this Order are repealed or modified accordingly. All other provisions stated in DO 003, s. 2024 and DO 022, s. 2023, not affected by these amendments, shall remain effective.
- This Order shall take effect immediately upon approval and after publication on the DepEd website and registration with the Office of the National Administrative Register (ONAR) at the University of the Philippines Law Center (UP LC), UP Diliman, Quezon City.
